YOUR LEGACY

When 13-month-old Indigo suffered a series of strokes a few weeks after having chickenpox she needed specialist paediatric care at a hospital 340 miles away.

Indigo was on holiday with her mum, dad, brother and a group of friends when she had to be admitted to the Royal Cornwall Hospital in Treliske, Truro after she stopped using her left arm and leg and the left side of her face was drooping.

Emergency scans revealed that Indigo had two masses on either side of her brain and abnormalities in her heart. While these investigations were being carried out she was having regular seizures that were getting worse each time they happened.

Eventually Indigo had to be sedated and transferred to the Intensive Care Department while decisions were made about how best to treat her.

Her mum Leighanne explains: "Staff at the Royal Cornwall Hospital decided this was a more serious condition than they were equipped to deal with and that Indigo would have to be transferred to another hospital. Consultants at Alder Hey Children's Hospital in Liverpool were contacted and spoken to via video link about the best course of treatment. It was decided to transfer her there by

helicopter which was a shock, but at the same time a great relief as I knew it was the quickest way for her to get the care she needed so urgently."

The Children's Air Ambulance took off from its base in Oxford and flew to Bristol to pick up a specialist retrieval team from Wales and West Acute Transport for Children Service (Watch) to fly them to the Royal Cornwall Hospital.

It took 2 hours and 18 minutes to fly from Truro to Liverpool compared with a road journey in a land ambulance of 5 hours 39 minutes.

"I couldn't believe all the equipment that was on the helicopter to treat Indigo and monitor her condition while we were flying. It was amazing. Most people have no idea that such intensive care takes place up in the sky," says Leighanne.

As soon as they arrived at Alder Hey, Indigo was taken to the High Dependency Unit where she was given medication and fluids and monitored.

After undergoing more scans and lumbar punctures, it was discovered that the strokes she had suffered had been caused by a bout of chickenpox that Indigo had suffered a few weeks before.

IS THEIR FUTURE +

"This viral infection (chickenpox) had caused Indigo's immune system to attack her brain stems and create clots in her brain which broke free and caused the seizures," explains Leighanne.

She stayed with her daughter in hospital for the 21 days it took to get her well enough to be discharged and go back to their home in Prestwich, Manchester. During that time Indigo was given intravenous antibiotics four times a day and had to have regular physiotherapy.

"I believe that without the Children's Air Ambulance and the team on board she would not have received the vital specialist treatment she needed so urgently as quickly as she did and may not have survived. You gave me her life" she adds.

COSTS INVOLVED

It's a common misunderstanding that including a gift to a charity in a Will is something that only the rich and famous do. In fact, we receive gifts of all sizes from people of all walks of life. A gift of any size can make a huge difference.

HERE ARE SOME WAYS YOUR GIFT COULD HELP...



£3,600

Could pay for the transfer of one child with the Children's Air Ambulance



£10k

Could pay towards flight helmets for the clinical partner teams to use in the helicopter



£35k

Could fly ten children to hospital - that could be ten lives saved



£60k

Could pay towards one bespoke state-of-the-art specialist transport stretcher



£120k

Could keep one helicopter in fuel for a year

WHY IS A WILL IMPORTANT?

Your Will is one of the most important documents you'll ever write, yet only half of UK adults have a Will. Without a properly drawn-up Will, you will be declared 'intestate'. This means that the Government will step in and decide what happens to your estate and any of your wishes will not be fulfilled.

Putting your affairs in order with a Will should simplify the legal process for your loved ones at what will be a very difficult time. Therefore, having a Will is important not only to you, but to your family and friends – ensuring your loved ones and your final wishes are respected. You can determine who you would like to benefit from your money, possessions, and property. If you have any dependants, you can name a guardian to make sure their future is safe and secure. You can set out any specific funeral arrangements.

Most people have more than they think. Did you know that copyrights, loyalty points, pets, photo albums, cryptocurrency and much more can be included in a Will.

Your Will is also an opportunity to remember causes that mean something special to you, such as the Children's Air Ambulance. We understand that providing and caring for your friends and family comes first. After you've made sure of that, we are asking you to consider including a gift to our charity. The Children's Air Ambulance depends on this type of gift. Gifts in Wills are responsible for 1 in 7 of our life saving missions.

Including a gift in your Will is also a great way to support the Children's Air Ambulance if you are unable to support us now as it won't cost you anything right now.

HOW TO REMEMBER THE CHILDREN'S AIR AMBULANCE IN YOUR WILL

+ STEP 1: Talk to a solicitor

If you don't already have a Will it is recommended that you get professional advice from a solicitor to ensure your Will is legal, and exactly how you want it. Of course, if you already have a Will it's important to keep it up to date. This includes when you purchase property, get married, have children or receive a large sum of money such as an inheritance. If you need to make major changes in your Will, you should speak to a solicitor who can amend it for you. Go to page 11 to find out about how to access a solicitor through our free Wills scheme

+ STEP 2: Decide who will benefit

Before you meet with a solicitor consider what you wish to leave to your family, friends and the charities you support. Make a list of what you own and what you owe. This will help you work out the true size of your estate, and what you could leave to friends, family and causes close to your heart.

+ STEP 3: Decide how you want to remember the Children's Air Ambulance

Your solicitor will ask you what type of gift you would like to include and the amount, or the specific details.

+ STEP 4: Our details

Your solicitor will ask you for our details:

+ STEP 5: Executors and witnesses

Your solicitor will ask for details of executors of your Will. Often, people will choose their solicitor or a family member to carry out the terms of their Will, to ensure their wishes are fulfilled. Naming them as executors does not stop them benefiting from your Will. When the Will has then been drawn up, you will need two independent people, who do not benefit from your Will, to witness your signature.

+ STEP 6: Thank you

Finally, we would love to be able to thank you for your generous gift. If you would be happy to do so, please let us know you have included a gift in your will to Children's Air Ambulance. (see page 15).

TYPES OF GIFTS

What types of gift can you include in your Will?

A RESIDUARY GIFT

A residuary gift is a percentage or share of your estate once all other payments and gifts have been made. This type of gift is popular as it keeps in line with inflation and remains proportional to the value of the estate. A residual gift is also a good option if you are unsure what your financial situation will be, as it's the percentage of what you can afford at the time of your passing.

A PECUNIARY GIFT

A pecuniary gift is a fixed, specific sum of money. This can be as large or small as you like. It is worth noting that over time the value could decrease with inflation. If you do choose a pecuniary gift, you may wish to review your Will from time-to-time to ensure it still reflects your intentions.

A SPECIFIC GIFT

A specific gift is a specific item or asset, such as jewellery, furniture, a car, or shares.

A GIFT AFTER A LOVED ONE PASSES

This type of gift allows you to leave assets to a loved one for the duration of their life. When they pass, this gift can then be passed on to your chosen charity.



USEFUL INFORMATION

KEEP YOUR WILL SAFE

Make a copy of your Will for future reference and keep the original with your solicitor. You can also register your Will with the National Will Register, for a small fee. See www.nationalwillregister.co.uk for further details.

FINDING A SOLICITOR

There is no law to say you need to use a solicitor, however, your Will is a legal document and it is important that the correct legal language is used. Sorting out mistakes made in a DIY Will could cost your family later, in both time and money. To find a local solicitor, contact the Law Society of England and Wales at solicitors.lawsociety.org.uk or call them on 020 7320 5650. Before you see your solicitor, you may wish to complete our checklist at the back of this booklet and take it with you to your appointment. The cost of your Will depends on how complicated it is and where you live. Ask your solicitor to make the cost clear at the start.

INHERITANCE TAX

It is good to know that when you include a gift in your Will to a registered charity, the gift is exempt from Inheritance Tax (IHT) and if your estate is more than the tax threshold, a gift can reduce the overall tax liability to your estate. The amount of the gift will be taken from your estate before any tax liability is worked out. Also, if you leave 10% or more of your estate to charity, this can reduce the rate of IHT from 40% to 36% on some assets. Please note that this information is no substitute for professional advice and IHT rates can change. Some assets may be exempt. Talk to your chosen solicitor to discuss in more detail. NATIONAL FREE WILLS NETWORK

Writing a Will need not be complicated, nor expensive, especially with our partnership with the National Free Wills Network.

Through our scheme, the National Free Wills Network can write or amend a Will at no cost to our supporters, and the Children's Air Ambulance will pay a discounted rate. Our partnership with the Network ensures that our supporters' estates will be dealt with as they intended.

Whilst there is no obligation to do so, we hope that you might consider including a gift to the Children's Air Ambulance in your Will to help us continue to be there for children in their greatest hour of need in the future. Including a gift to the Children's Air Ambulance in your Will - however big or small - will make a huge difference to our service.

HOW DO I APPLY FOR MY FREE WILL?

YOUR DETAILS

Your details will be passed onto the Network, who will send you a pack that includes a list of nearby participating solicitors.

WRITE YOUR WILL

Write your will with your chosen solicitor, in the usual way. Your solicitor will ask you to complete a form to enable you to participate in the scheme.

UNDERSTANDING LEGAL JARGON

ADMINISTRATOR

Someone who is legally appointed to manage your affairs if you die without a Will.

BENEFICIARY

A person, charity or organisation who receives something from your Will.

BEQUEST (LEGACY)

A gift left in a Will. It can be:

- Residuary: remainder of your estate after other gifts and payments have been made
- Pecuniary: a fixed sum of money
- Specific: a particular, named item

CODICIL

A separate document that makes a change or addition to your existing Will. A written amendment to someone's Will, saving the need to re-write the whole document. It should be signed, dated and witnessed with the same legal formalities as a Will.

ESTATE

The total value of everything you own at the time of your death.

EXECUTOR

The person or people you choose to carry out the instructions in your Will. This could be a relative, friend or your solicitor.

GUARDIANS

The people you choose to look after your children should you die.

INTESTATE

The name given to someone who dies without having made a Will.

INHERITANCE TAX

Inheritance tax is paid if a person's estate (their property, money and possessions) is worth more than £325,000 when they die. This is called the 'inheritance tax threshold'. The rate of inheritance tax is 40 percent on anything above the threshold. The rate may be reduced to 36 percent if 10 percent or more of the estate is left to charity. Some assets may be exempt.

LEGACY

This is another term to describe a gift in your Will.

PROBATE

The legal process that establishes if your Will is valid. If it isn't valid, an administrator is called in.

RESIDUE

What is left of your estate, after all gifts, debts, taxes and expenses have been paid.

TESTATOR/TESTATRIX

The name given to the person making the Will.

TRUST/EE

A trust is a way of managing assets, such as money, investments, land or buildings. The trustee is the person who manages the trust.

WITNESS

A person who acts as a witness when you sign your Will. They cannot benefit from your Will.
